GIFT AID

Did you know that for every £1 donated, Compton Care could receive an extra 25p from the government - at no extra cost to you! Under the Gift Aid scheme if you pay tax in the UK we can reclaim the basic tax rate (25%) on your gift. So for instance, if you donate £10 it becomes worth £12.50 to Compton.

To qualify for Gift Aid you will need to be a UK taxpayer and have paid sufficient Income Tax or Capital Gains Tax to cover to cover the amount of tax all the charities you give to will reclaim on your Gift Aid donations in the tax period in which they are received.
